AFFIDAVIT IN SUPPORT OF WARRANTLESS ARREST

Your affiant has been a police officer for the past 29 years. Beginning in 1991 your affiant worked in the Crime Against Children's Unit with the Lakewood Police Department. For the past 12 years, your affiant has worked as an investigator with the Jefferson County District Attorney's Office, assigned to the Crimes Against Children's Unit. Since October of 1996, your affiant has also investigated individuals who utilize the Internet to seek out children.

Between April 2, 2009, and April 3, 2009, Sgt. Troy Hendricks' and your affiant were online portraying a teenage girl under the age of fifteen. While portraying the teenage female under the age of fifteen, the screen name tgc_rn (Juan Ovalle) began communicating with the portrayed child in this case.

During this communication Ovalle asked the portrayed child her age and he was told the age of the portrayed child.

Eleven minutes into this communication Ovalle communicated, "Do you like older guys".

Ovalle asked the portrayed child if she had sex and again asked, "You really like older".

During this initial communication Ovalle asked, "Would you like to meet me?"

On April 3, 2009, at approximately 1024 hours on signing on as the portrayed child in this case I immediately received an instant message from Ovalle.

During this communication Ovalle said he was home today and "horny". Ovalle asked if the portrayed child's mom was home and when he found she was working stated, "I told you I want to meet you". Ovalle asked for the portrayed child's address and phone number.

On the portrayed child asking Ovalle what they were going to do on meeting he stated he would tell the child when he met her. Ovalle then asked the portrayed child to tell him what she liked when having sex.

Ovalle said, "I a pussy sucker" and "I like all my face to get wet".

Again during this communication the portrayed teens age was once again stated to Ovalle.

Ovalle asked for the portrayed child's address and phone number and he was provided the information.

Ovalle said he was going to come and he would be in a Green BMW.

At approximately 1105 hours Ovalle called and spoke with Investigator [REDACTED] who was portraying herself as the child in this case on the phone.

During the first phone Ovalle spoke with Investigator [REDACTED] stating he was going to meet her and they would have sex.


During a second phone call while Ovalle was driving he stated he wanted to fuck doggie and for the portrayed child to sit on his face. Ovalle asked the portrayed child if she "sucked dick" and if she swallowed.

On this date at approximately 1355 hours, I observed a Green BMW turn off of [REDACTED] onto [REDACTED]. The BMW drove slowly north up the street where on passing my location appeared to be the same person in the picture he had provided on April 2, 2009 to the portrayed child. The BMW drove obviously very slowly at which time I pulled in behind him and turned on my emergency lights and siren. The BMW proceeded to continue north on [REDACTED] turning east on [REDACTED] street ignoring the lights and siren. The BMW finally came to a stop at [REDACTED] and [REDACTED], County of Jefferson and the State of Colorado, at which time he was contacted and found to be Juan A Ovalle (Dob: 11-28-66) of 4753 Witches Hollow Lane, Colorado Springs, Colorado 80911.


Ovalle was arrested on the above charges.
